# **Description:**

The European Commission (EC) has set out to transform Europe more sustainably. In an effort to support the European Green Deal, the EC has introduced a series of new EU Regulations that will influence and impact corporate sustainability compliance.

Among the forthcoming pieces of legislation that have already been published, there are three main policies that stand out:

- 1. Corporate Sustainability Reporting Directive which concerns corporate sustainability reporting and replaces the existing Non-Financial Reporting Directive
- 2. Corporate Sustainability Due Diligence Directive which concerns the impact of companies on the environment and supply chains
- 3. Country-by-Country Reporting Directive which concerns the reporting of corporate taxes on a country-by-country basis

This session will provide participants with a summary of the three pieces of EU legislation; what impact they will have on companies; and how companies can better prepare for them. Therefore, participants can understand how the upcoming EU requirements might affect their companies and how to better future proof their businesses.
